What is the Census?



It is taking inventory and counting every person living in the United States once, only once, and in the right place.

How is the information used?



By law, your responses can only be used to produce statistics - and no other purpose. Your responses cannot be shared and cannot be used against you by any government agency or court in any way - not by the FBI, ICE, or even local police. All Census workers take a lifetime Oath to protect your personal information. Any violation comes with a penalty of up to \$250,000 and/or up to 5 years in prison.

Why do we need a count?

- 1. It's mandated by our Constitution.
- 2. People move and we reapportion and redraw our congressional and legislative districts based on an accurate count of people.
- 3. It's mandatory to complete and return the census.



How do you respond to the Census?





To complete the census, you answer a handful of questions online, by phone, or by mail. Choose the option that works best for you.

Process and Timeline

How will the 2020 Census invite everyone to respond?

What can you expect?



When it's time to respond, most households will receive an invitation in the mail. Every household will have the option of responding online, by phone, or by mail.

What you will get in the mail:



March 12-20

An invitation to respond online to the 2020 Census.



March 16-24

A reminder letter.



March 26-April 3

A reminder postcard.



April 8-16

A reminder letter and paper questionnaire.



April 20-27

A final reminder postcard before an in-person follow up.

Letter Invitation and Paper Questionnaire:

Most areas of the country are likely to respond online, so most households will receive a letter asking them to go online to complete the census questionnaire.

Areas that are less likely to respond online will receive a paper questionnaire along with their package. The package will also include information about how to respond online or by phone.

If you don't respond online, by phone, or by mail, we will follow up in person.





Facts





The Census Bureau combines your responses with other responses to produce statistical summaries. It is against the law for the Census Bureau to disclose or publish any identifiable information about an individual or household. All Census Bureau staff take a lifetime oath to protect your personal information, and any violation comes with a penalty of up to \$250,000 and/or up to 5 years in prison.
